



Terms and Conditions

➤ PARTS PURCHASES

- Credit terms - Net 30 days.
- Quotes are valid for 90 days.
- Future material price increases/decreases of greater than +/- 5.0% will be passed along to the customer within 30 days of receipt of new material price.
- Quote assumes bulk packaging unless otherwise specified. If different packaging is required then what has been quoted, pricing maybe adjusted based upon additional labor and/or packaging materials required.
- Pricing can be adjusted based upon final customer approved CAD and part drawing.
- EX Works-Albion, MI USA is assumed, unless otherwise specified on our quote.
- Pricing does not include part validation, performance testing, or any material testing.
- Pricing does not include any check fixtures or gages unless specified.
- Quote assumes general manufacturing cleanliness unless otherwise agreed upon.
- Quote includes up to 4 critical characteristic dimensions and 1 fit/function check in:
 - Capability studies and gage R&R during mold development/PPAP submission
 - Production quality checks
- Team 1 reserves the right to pass through via a surcharge its cost for any new duties, tariffs, or taxes it is required to pay because of any change in U.S. law on tariffs impacting imported materials or purchased components.

➤ MOLD PURCHASES

- Mold credit terms: First payment of 1/3 of total price due with Purchase Order (PO), Second payment of 1/3 due with First Samples submission, Final payment of 1/3 due at Team 1 PPAP submission.
- Mold quote does not include cost of any gages. Cost for gages to be determined upon definition of any special characteristics by customer and at time of notification.
- Quoted mold price and timing is based upon mold maker's current workload. Final price and timing dependent on when mold is sourced if later than 90 days from quote date.
- Timing starts when PO, material specification, approved part print and CAD data are received by Team 1 Plastics.
- Pricing may be adjusted based upon final customer approved CAD and part print.
- If a special trial is required (not tool qualification), then Team 1 will submit a quote based upon trial and sample requirements.
- Pre-series trial samples to be quoted at the time of request. May include freight, tariffs and trial setup costs. EX Works-Albion, MI USA.
- Team 1 quoted mold price includes capability studies and gage R&R up to 4 critical characteristic dimensions and 1 fit/function check during mold development / PPAP submission.
- Team 1 reserves the right to pass through via a surcharge its cost for any new duties, tariffs, or taxes it is required to pay because of any change in U.S. law on tariffs impacting imported molds.
- Team 1 will guarantee the mold for 1,000,000 shots. Any refurbishment/repair costs beyond 1,000,000 shots are the customer's responsibility.

➤ FAMILY MOLDS

- Quoted piece price is per part number.
- Sets - family mold assumes buying in equal sets to avoid an inventory imbalance.
- Imbalances – Team 1 will work with customer to develop economic way to balance any discrepancies greater than 5%.

➤ TRANSFER MOLDS

- Team 1 assumes that all transfer molds from their customers meet customer quality standards and consistently produce quality parts to meet production requirements.
- All regular and preventative maintenance will be covered by Team 1 Plastics.
- If mold requires any repairs related to mold design or construction, customer will be responsible for sourcing and paying for the repairs.

➤ PROTOTYPE MOLDS

- Credit terms: First payment of ½ of price due with Purchase Order. Final payment of ½ price is due with first part sample delivery.
- Prototype trial fees
 - 150 tons and smaller - \$500.00 (includes up to 300 sample parts with additional parts costing \$0.50 per shot).
 - 180 tons and larger - \$750.00 (includes up to 300 sample parts with additional parts costing \$0.75 per shot).
